

# Privacy Policy for Rayda

Welcome to **Rayda**. Rayda is a lottery forecasting company that offers users data-driven insights, statistical models, and tools to help analyze and forecast lottery trends. We respect your privacy and are committed to protecting your personal information.

This Privacy Policy explains how we collect, use, and safeguard your data when you interact with our services, including our website, mobile apps, or any related platform (collectively, the "Services").

## 1. Information We Collect

### a. Personal Information

When you register for or use Rayda's services, we may collect:

- Full name
- Email address
- Username and password
- Country of residence
- Age or date of birth (to verify legal age requirements)

### b. Usage and Technical Data

We automatically collect certain data when you interact with our platform:

- IP address

- Timestamps and session duration

### c. User Input and Forecasting Behavior

If you use Rayda's forecasting tools or enter preferences (e.g., lottery types, number selections, frequency of play), we collect:

- User-generated data, such as selected numbers or saved forecasts

- Search queries and filter settings

## 2. Legal Age Requirement

Our services are intended only for individuals who are **18 years or older** (or the minimum legal age for gambling-related content in your jurisdiction). We do not knowingly collect data from individuals under this age. If we discover such data, we will delete it immediately.

## 3. How We Use Your Information

We use your information to:

- Provide and personalize our lottery forecasting services
- Improve our algorithms, tools, and user experience
- Send important updates, account alerts, and marketing communications (opt-in only)
- Prevent fraud and enforce our terms of service
- Comply with legal and regulatory obligations

## 4. How We Share Your Information

Rayda does **not sell** your personal information. We may share your data only:

- With trusted third-party service providers (hosting, analytics, payment processors)
- If required by law or to protect our legal rights
- In connection with a business transfer (e.g., merger, acquisition)

All third parties are required to maintain the confidentiality and security of your data.

## 5. Cookies and Tracking Technologies

We use cookies and similar technologies to:

- Save user preferences
- Analyze user behavior for feature improvement
- Deliver personalized content

You can control cookies via your browser settings but disabling them may limit functionality.

## 6. Your Rights and Choices
